1. The seat allocation of the College is – (i) intake = 300 Management = 24 seats, supernumerary seats = 10 (five each for the University and the College) meaning thereby the college was having 334 seats in the academic session 2011-12.
2. As per student teacher ratio of 1:15 the college should have 20 permanent faculty members.
3. Presently the college is having only 02 permanent faculty members and rest of the faculty is on adhoc basis. The Committee Members desired that the faculty working on adhoc basis be regularized at an earliest as the same deficiency was also pointed out in the last year Inspection report.

### FINAL RECOMMENDATIONS

After conducting inspection of the College vis-à-vis the prescribed norms, the Committee recommended that Trikuta College of Education, Nardni Raipur (Bantalab Road ), Jammu be granted extension of temporary/provisional affiliation for imparting instructions in Bachelor's Degree Course in Education ( B.Ed.) for the academic session 2012-13 subject to the condition that the Chairman of the college shall submit compliance report for removal of deficiencies pointed out by the Inspection team within one month from the date of issuance of inspection report.
