

1. The total intake capacity of the College is 116, out of which 107 students were admitted during the session 2014-15. The College management has informed that the students have gone for micro-teaching on the day of inspection.
2. No books have been purchased by the College. However, order for purchase of books has been placed during the session 2014-15 (on March, 2015).
3. The College have eight faculty members which include Principal also, out of which only one is on permanent basis, rest of the faculty members are on ad-hoc basis including Principal. The Inspection Committee directed the management of the College to recruit permanent faculty through duly constituted Selection Committee.
4. Sufficient number of Computers are available including Internet connectivity.
5. No management meeting was held during the last 7 years. The last meeting was held on March 2008. The Inspection team directed the management to conduct the management meeting at the earliest.
6. No Selection Committee meeting was held <sup>since</sup> during the last 2006.
