11. OBSERVATIONS/DEFICIENCIES

- 1. The college has a total of 14 faculty members and only 04 faculty members are selected through University Selection Committee and rests are contractuals. The inspection committee directed the management to conduct selection committee for Principal and other faculty members at the earliest.
- 2. The college has not purchased books for the Academic Session and the same was strongly objected by the Inspection team. Inspection committee directed the management to purchase books at the earliest.
- 3. The computer lab. has only 11 computers and Inspection committee desired that all the machines need up-gradation and should have internet connectivity.
- 4. The last management committee meeting was held on 17.06.2011. The inspection committee desired that same be held at the earliest.
- 5. For the current session, only 38 candidates out of 216 were present and college has not issued any notice to the non-attending candidates.
- 6. Some of the faculty members are in-eligible to teach subjects like Mathematics, EVS, Science and Punjabi. The inspection committee directed the management to recruit the eligible faculty members at the earliest.

In contradiction to the University guidelines, some of the faculty members are still being paid through Cheque/Cash. Inspection committee directed the management to do away with this practice immediately and salary should be directly credited to the salary account of the faculty members.

FINAL RECOMMENDATIONS

After conducting inspection of the College vis-à-vis the prescribed norms, the Committee recommended that Sher-e-Kashmir College of Education, Gaddi Garh, Jammu be granted extension of temporary/provisional affiliation for imparting instructions in Bachelor's Degree Course in Education (B.Ed.) for the academic session 2012-13 only subject to the condition that the Chairman of the college shall submit compliance report for removal of deficiencies pointed out by the Inspection team within one month from the issuance of inspection report to the college.
