






SHER-E-KASHMIR COLLEGE OF EDUCATION

1. The total intake capacity of the College is 94, out of which 56 students were admitted during the session 2014-15. On the date of inspection only 24 students were present.
2. The College has eight faculty members including the Principal. Only one faculty member is selected through Selection Committee and the rest of the seven including Principal are on ad-hoc basis. The Inspection Committee directed the Management to conduct the Selection Committee for the faculty members and the Principal at the earliest.
3. The faculty members teaching the subjects of English, Social Science and Science are not qualified in their concerned subjects. The Inspection team directed the management to recruit the eligible teaching faculty at the earliest.
4. Last management meeting was held on 19-4-2014. The Inspection Committee asked the management to continue the process for holding the meetings of the Management Committee regularly.
5. The College has purchased the books amounting to Rs. 28,137/- during the last two years.
6. The Computer Lab has sufficient Computers but the Inspection Committee could not checked the Computers because of failure of electricity. No Internet connectivity was available.
7. The Inspection Committee observed that no Librarian was available in the Library.
