Moreover the College has also engaged teachers on lecture basis to teach optional subjects.
- 2. The College has maintained the teacher student ratio 1:15.
- 3. Last Management meeting of the College was held on 5-2-2015 and the Selection Committee was held on October, 2011. The Inspection Committee directed the College to appoint Principal on permanent basis through duly constituted Selection Committee.
