



1. The total intake capacity of the College is 116. During the date of inspection 83 students were present and 33 were absent. The College is having seven faculty members including the Principal, out of which six faculty members have been appointed by the duly constituted Selection Committee and the Principal has been appointed by the Management. Moreover the College has also engaged teachers on lecture basis to teach optional subjects.
2. The College has maintained the teacher student ratio 1:15.
3. Last Management meeting of the College was held on 5-2-2015 and the Selection Committee was held on October, 2011. The Inspection Committee directed the College to appoint Principal on permanent basis through duly constituted Selection Committee.
