



1. College management has appointed some of the faculty members on ad hoc/contractual basis & the same should be regularized through university selection committee.
2. College should make efforts to improve attendance of student.
3. College has allotted more than 60 students per section and the same is not permissible. College should not allot more than 60 candidates per section.
4. The faculty members selected through University selection Comm should be paid minimum salary @ ₹ 12,000 per month.
5. The college has not added any book to the library after 11 year. 2013. The same deficiency was pointed out by the last inspection team.
6. College should have regular & eligible faculty for IACT. The law was for IACT is required for one month only. re

7. Computer lab needs upgraded machines and requires complete makeover.


FINAL RECOMENDATIONS OF THE INSPECTION COMMITTEE:


