1. Although most of the faculty members have been appointed through Univ. but principal and rest of the staff should be appointed through University Selection Committee.
2. Presently there is no teacher ~~for~~ for Computer Science as the concerned teacher has left the job w.e.f. Sept. 2014. Moreover there is no teacher for Teaching of Science.
3. College has spent only ₹ 5829 for purchase of books and same is not adequate and college needs to spend more on books.
4. College should make efforts to improve attendance of students in the college.
