

- Only 35 candidates were present at the time of inspection. College should make efforts to improve the attendance of the candidate.
- pirated softwares and Tests should be avoided. College should purchase licensed softwares and aptitude Tests.
- College should add quality books in the library. It was further noticed that more than 50 copies of the same books were purchased by the college.
