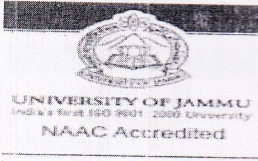

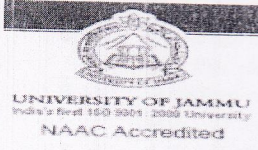

**OBSERVATIONS/DEFICIENCIES:**

1. The PPT (Power Point Presentation) was not presented to the Inspection team because there was no responsible person from the college administration/Management to have undertaken the responsibility of the Presentation.
2. As per the Teacher-Student ratio (1:15) is adequate as the college has twenty one faculty members (Nine permanent and Twelve on adhoc basis). The college should have 21 permanent faculty members against the admitted student strength of 319 for the session 2014-15.
3. The Principal of the College has not been selected through proper Selection Committee as evident from the available records. Moreover, Hon'ble Vice-Chancellor authorized Dr.


Saifullah Khan as Principal of New Age College of Education on adhoc basis for a period of one year.


4. The Inspection committee members observed that the salary to the faculty members is not being paid as per UGC/AICTE norms.
5. The number of students present in total including all the three sections was 201 against an admitted strength of 319. This is a situation regarding the number of students attending the college on a day when the University team visiting the college is notified in advance.
6. The college is said to have purchased books (361No.'s) worth Rs. 1,06,290/- during last two years.
7. During the inspections of the classes the committee members found that the college does not followed the time-table strictly and also found that the teachers were confused in the class rooms.


**FINAL RECOMENDATIONS OF THE INSPECTION COMMITTEE:**

After conducting the inspection of the college vis-à-vis the prescribed norms, the committee recommended that the college be granted extension of temporary/provisional affiliation for imparting instructions in Bachelor's Degree Course in Education (B.Ed.) for the academic session 2014-15 subject to the condition that the Chairman of the college shall submit compliance report for removal of deficiencies pointed out by the Inspection team.




