OBSERVATIONS/DEFICIENCIES

The inspection committee was received by the Chairman and Principal of the College where among others faculty members of the College were also present. The committee members were apprised about the activities of the College during the last academic session by giving power point presentation in the Principal's office. A hard copy of the power-point presentation is attached with the report. Thereafter the Chairman and Principal accompanied the committee members for having round of the college building. The members visited the computer labs, class-rooms, library, multipurpose hall and mess and found that the college has adequate infrastructure for imparting instructions to B.Ed. programme. Because of breaks, no student was found either in the Hostel or in the College. The committee members noted that one guest house comprising two rooms has been constructed during the last year. The college has also added computers, printers in the computer lab. The committee noted that the college has not added the required number of books in the library for which the Chairman was advised to add the yearly required (as per University norms) number of books in the Library.

The inspection committee also perused the last inspection report of the said College and noted that it was advised by the last inspection team to regularize the faculty working on adhoc basis at an earliest. Further the annual increment to the permanent faculty members be released periodically. The committee noted that the college is in the process of conducting selection of the staff. The Principal was advised to conduct the selection committee meeting in the month of January, 2013. As regards, release of increment the matter is under active consideration of the Management for which the Chairman has assured the committee members that the increment will be released immediate after the management committee meeting is held. The committee also noted that the college has adequate number of books in the Library. The Committee members were informed that this year only 256 students sought admission in the college as compared to 307 students admitted last year against the sanctioned seats of 334 (including management and social infrastructure fund seats).

The College is accredited by NAAC with Grade "B", the validity of the said Certificate of Accreditation is upto December 30, 2014..

RECOMMENDATIONS

After conducting inspection of the College vis-à-vis the prescribed norms, the Committee observed that the College has adequate infrastructure, faculty and other required facilities for imparting instructions to B.Ed. programme. The committee, therefore, recommends grant of extension of temporary affiliation to Shri Vaishno Devi College of Education, Reasi with the existing sanctioned intake for the academic session 2012-13 subject to the condition that the Chairman of the Institute shall give an undertaking on the stamped paper of proper value that the deficiencies pointed out by the Inspection team shall be removed before the start of the admissions for the next
