The Inspection team observed that the college management has complied with the deficiencies pointed out by the Inspection Team which conducted the inspection of college last time except the sallery paid to the staff which is not as par the university norms laid down by the university from time to time which needs to be addressed shortly by the college management.

The College had added 910 new books in the library of the College and the teacher student ratio is satisfactory and 22 teaching faculty are working at the time of inspection as compared to 15 at the time of last inspection.

Students facilities and other activities were adequate.

12. FINAL RECOMMENDATION

Keeping In view of the above mentioned observations The Inspection team

Recommends that the college be granted temporary provisional affiliation for year i.e. 2014 -2015 subject to the fulfillment of the above mention subject to deficiencies pointed out above by the committee with in a stipulated period. the University Of Jammu for the purpose.
