

Major Deficiencies needs to be attended on priority:

- ① The college is understaffed, they have only 6 teachers out of 2 which one is only M.Ed. (Nalwinder Kaur).
- ② One faculty Sumilla is only MA Eng & B.Ed,
- ③ Psychology, language competence, inclusive education are not being taught by qualified faculty.

4) The college needs 8 faculty for 2 basic units of 50 each.

5) The college has no lectures identified/selected for fine arts, performing arts or physical education.

6) The salary structure needs to be redefined for permanent staff appointed through selection committee as no annual increments & no grades are enhanced for staff rendering service for more than 5 to 8 yrs.

Minor deficiencies/suggestions:

7) It was observed that many permanent appointed lecturers figuring at S.No 2, 3, 4, 6, 11 & 12 of Annexure I were not shown in list of faculty submitted to Inspection Committee.

8) Building earmarked for college of education should be used for sole purpose of teacher training, renting of multipurpose hall & other facilities should be avoided.


