OBSERVATIONS/DEFICIENCIES/SUGESSTIONS (IF ANY):

The committee members observed stagnation with respect to the growth of the academics of the college. No additions/improvement in infrastructure, academic activity, faculty development initiatives were seen. No cognizance of the deficiencies as pointed out in 2011 was taken. The committee felt that it is a mere wastage of resources to visit year after year when the college management least bothers to improve its pathetic condition.

The Committee pointed out following deficiencies on the inspection of the college:

1. The college has not conducted selection committee meeting since 2011, and has only four lecturers working on permanent basis. It was noted that

this was a persisting deficiency of the college as pointed out in previous inspection also.

2. There is no principal appointed, however one lecturer has been given the

charge of principal.

- 3. The look of the college was deserted and unkempt. Only 5 students were found present out of the 76 students enrolled for the session 2014-15.
- 4. There was no record of when the last Management Committee meeting was convened by the college.
- 5. No seminar or extension lectures have been arranged by the college in the last session. Some teachers have participated in one/two seminars held in other college but the feature is not regular and there is no such activity seen for students.
- 6. The Committee observed that increment pattern of salary was not defined, the salary has been increased arbitrarily teachers with dual qualification are paid less.
- 7. There was no internet connection in the computer laboratory, the CPU were connected to direct supply of electricity; no UPS were purchased for the laboratory. There was no air conditioning in the lab and is in poor condition.
- 8. The assessment test papers of the students were without date and year. Even the teachers who had checked the papers didn't put any date. The question papers were hand written and again without date and session.
- 9. The lecturers are still being paid salary through cheques irrespective of the directions to deposit it directly in their bank accounts.
- 10. Librarian is not appointed through selection committee, the library record was not proper, the journals are present but not subscribed regularly

FINAL RECOMENDATIONS OF THE INSPECTION COMMITTEE:

The Committee after making the necessary inspection recommends that the extension to the temporary/ provisional affiliation for the session 2014-15 be given keeping the future of the students already enrolled in the college

The college be given one month's time to improve the infrastructural deficiencies and appoint faculty following the due recruitment process. In case the college fails to comply with the above mentioned conditions. The Committee proposes that the admission for the session 2015-16 be not made.
