OBSERVATIONS/DEFICIENCIES/SUGESSTIONS (IF ANY):

The Committee pointed out following deficiencies on the inspection of the college:

1. The committee observed that the college has recently convened its selection committee meeting and has 5 regular lecturers, while 4 are working on adhoc basis, the management committee meeting has also been recently held. However the faculty appointed through selection committee will join the college from the new session.

- 2. The college has conducted one out reach activity on youth policy, one workshop on teaching aids, a sports meet and a slogan writing competition in last session. No guest lecture from College or Universities were organised.
- 3. The Committee observed that the library although have 2582 books but no book has been added in last session there are no e-journals or printed Journals subscribed by the college. The college keeps a xerox copy of some journals available on internet. The committee asked the management to subscribe journals or e- journals for the reference of faculty and students.
- 4. The Committee observed that the salary of the employees is still being given through cheques; the committee directed the management to divert the salary directly to the bank account of the employed faculty. Also it was seen that some of the faculty were being paid 8000/- even after their selection through selection committee, which was not as per norms. The committee asked the management to increase their salary and pay atleast 12,000/- p.m plus annual increments regularly. Increments and bonuses were being given without following any guideline. The committee felt there is a strong need to revise salary and follow the norms in paying increments.
- 5. The Committee proposed that separate budgetary provision should be allocated for library/lab, FDPs and research related activities at the start of the session.
- 6. The committee observed that the notices issued by the principal were without any number and date. The college classwork had been suspended since 20/5/2015 completing 180 days of teaching, which was not in accordance with the academic calendar.

FINAL RECOMENDATIONS OF THE INSPECTION COMMITTEE:

The Committee, therefore, recommends the grant of temporary affiliation in favour of Kawa College of Education for the academic session 2014-2015 subject to the condition that the Chairman of the college shall remove the deficiencies pointed out by the inspection team as indicated in the inspection report w.r.t point numbers 2,3,4,6 before the start of next session.
