

7. OBSERVATIONS/DEFICIENCIES :

The seat allocation of the College is (i) intake = 270, Management = 22 seats., supernumerary seats = 10 (five each for the University and the College) meaning thereby the college was having 302 seats in the academic session 2012-13. But only 189 seats have been filled for the said session. As per student teacher ratio of 1:15, the college should have 18 faculty members in case of full enrolment, but the college was having 14 faculty members which the Inspction Team noted that as per enrolment, the strength of the teachers was sufficient for the academic session 2012-13. The College is having permanent Principal.

The Inspection Team noted that in January, 2013, the college was inspected for grant of affiliation but due to non-availability of staff and students, the said committee constrained to recommend the grant of extension for the year 2012-13. Accordingly, a show cause notice was served upon the said college on 3.4.2013 giving seven days notice for response. The College responded to the said notice on 17.4.2013.

The Inspection team ^{went} ~~gone~~ through the response of the College to the said show cause notice and checked with the record available with the College and found that most of the deficiencies have been removed except that the college has invested Rs.14061.00 (against Rs.50,000) for purchase of books for the academic session 2012-13. In view of the fact that the college has already 2325 books available in the library, the committee therefore was of the view that these books are sufficient for the students enrolled for the current session. However, the college management was advised to invest the required amount for the library.


The inspection team, after power point presentation by the College, interacted with the faculty members and also perused the time table of B.Ed. Class for the Session 2012-13, noted that attendance of students for the session 2011-12 remained satisfactory as per attendance registers made available to the team by the Principal of the College.

The Committee noted that the faculty has been appointed through proper selection committee constituted by the University on 9th of April, 2013. But two faculty members have left the job for which the management has made adhoc arrangement. It was therefore advised the management to conduct selection committee meeting before the start of new academic session and keep regular faculty strictly as per teacher-student ratio. The team also observed that no Management Committee meeting has been held during the last session for which the College management was advised to convene the meetings of the Management Committee regularly.


FINAL RECOMMENDATIONS




