A copy of the inspection report is enclosed herewith for information necessary action at your end.






Report of the Inspection Committee for the inspection of Bhagat Kabir College of Education for extension of temporary affiliation for the session 2016-17

5. The committee instructed the college to credit the salary of the faculty member directly to their bank account to maintain transparency.


Recommendations of the Inspection Committee
