OBSERVATIONS/DEFICIENCIES/SUGESSTIONS (IF ANY):

The committee members after physically inspecting the college and verifying the details of the compliance submitted by the principal **pointed out following:**

1. The college has not conducted the interviews through selection committee till date however the Principal informed that the posts have been advertised in the newspapers on 8/7/15 in state times and again on 27th





July 2015 in daily excelsior. In response only two candidates have applied for teaching of Science and one for teaching of Urdu. The college has got the panel approved from the university and communicated to college vide letter no: CDC/2015/2875-77 dated 23/7/15. Thus the college is going to convene selection committee shortly.

2. The Committee checked and found that in compliance to deficiency stated at point 2, the college has paid for the subscription of new Journals namely: Journal of Indian education, Indian Education Review, Prathmik shikshak and Bhartiya Adhunik Shikshak.
3. To check the status of the computer laboratory, inspecting team physically visited the computer laboratory, the team had to wait for half an hour before some technical issues due to the electricity fluctuations were resolved, the team found that the computers were working and had internet connectivity. The bill for broadband as paid from 1/3/15 to 31/3 15 was submitted by the college as supporting document for their claim.

RECOMENDATIONS OF THE INSPECTION COMMITTEE:

The Committee thus recommends that the extension to the temporary/ provisional affiliation for the session 2014-15 be given in favour of Jan College of Education. Also the college be given one month's time to convene selection committee meeting to appoint faculty as per new statutes and scheme for two year B.Ed course.
