#### **OBSERVATIONS/DEFICIENCIES/SUGESSTIONS (IF ANY):**

The committee members observed a careless attitude on the part of college management, as the record was not properly showed/ maintained even after giving a second date for inspection. The inspection of the college was first fixed on 6/3/15 however in absence of any response from the college; the inspection was rescheduled on the request of the principal on 23/3/15.

**The committee pointed out following deficiencies on the inspection of the college:**


1. The college has no principal, the principal of Degree College, BBA/BCA is looking after the administrative affairs of the College of Education in addition to her existing duties. The college was asked to appoint principal through proper selection committee separately for the College of Education.
2. The time table of the college was not properly maintained. The faculty teaching compulsory subjects did not possess the required qualification. PTLP is being taught by Mr. Nipun sharma who was appointed for teaching of mathematics. The committee asked the college to appoint teachers with necessary qualifications for compulsory subjects.
3. There was no teacher for Teaching of Urdu and Teaching of Science. The subjects are being taught by ineligible temporary arrangements. The college is required to provide teachers for all teaching subjects as are opted by the students.
4. The principal herself is teaching faculty of the college, while simultaneously managing as administrative head of three colleges of new modern society. Principal should be appointed after proper advertisement and Selection committee meeting
5. The last selection committee was held in 2011 followed by management committee meeting in 2012. Since then no management committee meeting has been called.
6. The college has deposited only Rs 3.00 lac as endowment fund, an amount of 2 lac is still pending against the college, which they have not deposited even after number of requests and warnings by the CDC wing of the university.
7. No seminar (education related topics) or extension lectures were arranged by the college in the last session. The power point presentation given by the management of the college before the inspection team appeared to have been made generally and was not specific to college of education, thereby lost its relevance.
8. The librarian was absent on the day of inspection. There was no one to physically show the record and additions made in the library. The photocopy of the bills however was provided to the committee.
9. The attendance record showed the presence of 8 students out of total of 120 students admitted to the education programme, but on physical verification, no student was found present.
10. There has been no participation of the faculty of the college in any refresher or orientation course for updating their knowledge and inturn contributing to the education system. The college management should encourage faculty for participation of its staff in such programmes, regularly organised by the ASC of Jammu University.


**FINAL RECOMENDATIONS OF THE INSPECTION COMMITTEE:**




