1. No staff including teaching as well as supporting staff was present in the college. The Committee was informed that the staff discontinued since there were no student allotted to the college for the session 2015-16. Son of the chairman who was available for interaction informed the committee that the necessary staff will be engaged after the affiliation is granted followed by admission of students to the college.
2. Entire premises of the college was giving a shabby look, full of dirt and giving foul smell. It appeared that the college building opened only on the day of inspection.
3. On asking about the cash book entries, the committee was informed that there is no transaction during the session 2015-16

Keeping in view the above the committee observed that the college has not prepared for the inspection and no sign of enthusiasm was found to start a new session. The committee, therefore, is of the opinion that the provisional affiliation to the college for the session 2016-17 cannot be granted.


