ORDER

Whereas, as per statutes, the Colleges have to deposit State Govt. NOC to the University by October every year for the course to be run in the following year.

Whereas, NOC for 2012-13 have been submitted by Private affiliated B.Ed./ M.Ed. Colleges for 2012-13 in June/July 2012.

Whereas, the academic calendar for B.Ed. envisages the start of classes from first week of October and as such the admission process has to start.

Whereas for admission notification, the B.Ed. Colleges to be notified have to be affiliated to University and in normal course, the causing of inspection before grant of affiliation in case of 72 B.Ed. Colleges shall take longer time thereby defeating the academic calendar.

Now, therefore, keeping the student interest in mind, it has been decided that the Vice-Chancellor in anticipation of the approval of the competent bodies is pleased to authorize extension in provisional affiliation to run B.Ed. Course in favour of the following colleges for the Academic Session 2012-13, subject to the condition that the colleges shall furnish an undertaking by 24<sup>th</sup>, August 2012 that they shall abide by the decision of the University with respect to affiliation till the inspections shall be undertaken:

**11. OBSERVATIONS/DEFICIENCIES**

1. The seat allocation of the College is – (i) intake = 300 Management = 24 seats, supernumerary seats = 10 (five each for the University and the College) meaning thereby the college was having 334 seats in the academic session 2012-13. As per student teacher ratio of 1:15 the college should have 22 permanent faculty members. Since the college has filled 300 seats the total faculty members should be 20 instead of 18.
2. The college has not conducted the selection committee for appointment of faculty and the same was pointed out during the last year inspection also.
3. The inspection committee desired that college should organize programmes for faculty improvement and teaching faculty should be encouraged to attend Orientation, Refresher Courses.

## FINAL RECOMMENDATIONS

After conducting inspection of the College vis-à-vis the prescribed norms, the Committee recommended that Dogra College of Education, Bassi Kalan, Bari Brahmana, Jammu be granted extension of temporary/provisional affiliation for imparting instructions in Bachelor's Degree Course in Education ( B.Ed.) for the academic session 2012-13 subject to the condition that the Chairman of the college shall submit compliance report for removal of deficiencies pointed out by the Inspection team within one month from the date of issuance of inspection report to the college.
