This has reference to your letter no.CDC/2015/5910-11 dated: 17-12-2015 regarding deficiencies pointed out by the University Inspection team who conducted the inspection of this college on 03-12-2015. The directions issued are complied within letter and spirit.

1. So far as deficiency regarding non conduct of Selection Committee for selection of teachers is concerned. It may be stated that college management had conducted meeting of Selection Committee for Selecting teachers in various disciplines on 17th May, 2016 in the college premises. Now the college has engaged eligible teaching staff as approved by the Selection and Managing Committee.

2. So far as deficiency regarding conduct of management committee is concerned, it may be informed that the college had conducted Management Committee Meeting on 9th June, 2016. As such minutes of the meeting are enclosed for your reference and record.

3 So far as deficiency regarding purchase of new books according to new B.Ed. curriculum is concerned, it may be further added that the college has purchased books upto Rs. 10,000/- already for first semester and upto Rs. 5800/- for second semester now.

4. Lastly deficiency regarding appointment of Principal on regular basis is concerned, it may be stated that earlier the interview for the post of Principal was scheduled to be held on 8th Jan, 2016. But due to some unavoidable circumstances it could not be conducted. But now the process of the same is being going on and as soon as the fresh date regarding the same will be confirmed, we shall intimate you.
