- 2. To permit private affiliated Colleges to admit students in these courses on their own, subject to the following conditions:
 - The candidates to be admitted by the Non-Government Colleges in the above courses, must fulfill all eligibility conditions, other than qualifying the JUET prescribed by the University and other Statutory/Regulatory bodies for admission to these courses from time to time.
 - ii) The Private Affiliated Colleges shall strictly adhere to the Admission / Academic Calendar as prescribed by the University for Government Colleges / its own Teaching Departments. Any admission made after the prescribed cut off date shall not be regularized under any circumstances.
 - The admission shall be made on the basis of inter se academic merit of the candidates by the Colleges through an Admission Committee, to be duly approved by the Dean Academic Affairs consisting of the following:
 - a) Principal of the College
 - b) Two Teachers of the concerned College

In case of tie between two Applicants for admission, the candidates having higher marks at 10+2 level shall be considered. If again there is a tie, marks secured by the candidates at Matriculation level shall be considered. Still in case of equal merit, the candidate older in age will be considered.

In case of any wrong admission or admission to ineligible candidate(s), the Principal of the College/Incharge, Admission Committee shall be responsible for the same and the College shall also face legal consequences, if any, arising out of or in connection with the said wrong admission(s). The University shall impose a penality of Rs. 50,000/- on the College for each wrong admission and the College shall be responsible to pay the same as and when demanded.

- v) Any admission made by a College over and above its intake quota (normal and/or management) would be an unauthorized admission as provided under Statute 21.10 of the Statutes governing Affiliation of Colleges and other Institutions, and necessary action as warranted under the above Statutes shall follow.
- All admissions shall be provisional subject to confirmation by the University. If at any stage, it comes to the notice of the University that the College has granted admission to a candidate on the basis of fake / forged documents and/or on the basis of qualifications not recognized by the University, such an admission shall be nullity ab initio and would be cancelled without affording hearing to the concerned candidate. The candidates must ensure and satisfy themselves before seeking admission in a particular programme that they possess the prescribed eligibility criteria for that course.
- vii) The candidates desirous of seeking admission to the above said courses in Non-Government Colleges shall fill up Admission Form Online available on the University Website or at other Website as shall be decided in due course of time.
- Viii) The Colleges shall mail the list of candidates admitted by them in the above said programme to the concerned Section/Department of the University immediately on the date following the one prescribed as last date of admission.
- The Examination Centres for the students of Non-Government Affiliated Colleges / Institution in the above programme shall not be constituted in their own Colleges but shall be constituted in the University Campus. In case of non availability of Examination Centres in the University Campus, Examination Centres for such students be constituted at the nearby Government / Non-Government Colleges so as to maintain the sanctity of Examination system at all times in accordance with the mandate of Resolution No: 3.3.1 passed by the University Council in its 75th meeting held on 11-10-2013.
- x) For such courses which are regulated by AICTE, the management seats shall be inclusive of total intake capacity and for the courses, such as, M.Ed., LL.B., B.Ed., BCA/BBA management seats shall be over and above the sanctioned intake capacity of the Colleges. Admissions against the management quota seats shall be made only after filling up the normal quota seats and shall be completed within ten days after the prescribed cut off date of admissions and the list of the candidates admitted against management quota seats shall be mailed to the Office of the Dean Academic Affairs immediately on the next working day.
- xi) The Colleges shall remit the University fee to respective Departments of the University within ten days after the close of the admission process.
- xii) In such Colleges where the admission to the above courses is less than twenty students, students admitted in such Colleges shall be shifted to the nearby Non-Government Colleges as per the choice of the student subject to availability of seat in that College. If there is no seat or the students did not opt to take admission in that College, the admission of the candidate(s) shall be cancelled and tuition fee deposited by the candidate shall be refunded by the College subject to such permissible deductions as may be worked out by the University.
- xiii) To maintain the uniform academic standards, the practicals and viva-voce of project work. etc. shall be under the overall supervision of HOD/Director of the concerned University Department.

- v) Any admission made by a College over and above its intake quota (normal and/or management) would be an unauthorized admission as provided under Statute 21.10 of the Statutes governing Affiliation of Colleges and other Institutions, and necessary action as warranted under the above Statutes shall follow.
- All admissions shall be provisional subject to confirmation by the University. If at any stage, it comes to the notice of the University that the College has granted admission to a candidate on the basis of fake / forged documents and/or on the basis of qualifications not recognized by the University, such an admission shall be nullity ab initio and would be cancelled without affording hearing to the concerned candidate. The candidates must ensure and satisfy themselves before seeking admission in a particular programme that they possess the prescribed eligibility criteria for that course.
- vii) The candidates desirous of seeking admission to the above said courses in Non-Government Colleges shall fill up Admission Form Online available on the University Website or at other Website as shall be decided in due course of time.

- xiii) To maintain the uniform academic standards, the practicals and viva-voce of project work. etc. shall be under the overall supervision of HOD/Director of the concerned University Department.

- xiv) The admission to non local candidates in Non-Government Colleges shall be granted under the second preference category, subject to availability of seats.
- xv) The Colleges can advertise the courses on their own in a transparent manner after seeking approval of the Dean Academic Affairs.
- The Office of the Dean Academic Affairs shall devise and Admission Form to be filled by the candidates seeking admission to the Non-Government Colleges on the pattern of JUET Online Form, in coordination with external agency to be hired by the Office of the Dean Academic Affairs.
- xvii) The private Colleges shall deposit facilitation fee @ Rs. 2,000/- (Rupees two thousand only) per course per year in the Office of the Dean Academic Affairs to facilitate the admission process.



Sub: Extension of provisional temporary approval of affiliation to Ashoka Law College, Kahtua, Jammu for 3 year LLB as well as five year BA LLB Law Course.

The Bar Council of India has considered the matter regarding grant of extension of approval of affiliation to the Centres of Legal Education which have applied for further extension and deposited the requisite inspection fee. Since the inspection of the above Centre of Legal Education has been carried out and decision to be taken which is pending before the Legal Education Committee. Therefore, Council passed the following resolution in this regard:

W--

It appears to be very difficult for the Council to undertake all the pending inspections of the existing institutions due to paucity of time. The academic session 2013-2014 has already begun and under these unavoidable circumstances, the Council resolves that existing Centres of Legal Education which have applied for extension of approval for the session 2013-2014 and have deposited the requisite inspection fee be granted approval of affiliation for the academic year 2013-2014 only. It is to be noted that the Council shall have to complete the process of inspection before the next approval in the light of the provisions of the Advocate Act, 1961 contained section 7(i) read with Section 7 (m) along with the rules namely, the Bar Council of India Rules, Part IV namely Rules 16,17 and 18. It is made clear that the above said resolution shall not apply to the following:-

1. Institution will have to deposit the inspection fee for the further approval of extension, if the period of three years has lapsed But this deemed extension would not apply in cases of law colleges, whose approval of affiliation have been declined by the Legal Education Committee of the Bar Council of India.

:2:

- 2. The new centres of legal education which have applied for approval of affiliation or recognition of Bar Council of India.
- 3. The application for new courses or section by Centres of Legal Education. To clarify it is stated that if an existing centre of legal education applied for additional section or new course then no automatic approval is deemed to be granted based on the above resolution.
- Those Centres of Legal Education which has been declined approval by Bar Council of India for the year 2012-2013 but has been given liberty to apply again.

It is further made clear that the extension of approval of affiliation now granted is coterminous with the affiliation granted by the University."

Since the aforesaid law college has applied for further extension in time. The college is allowed to take admission for the academic year 2013-2014 with existing strength in respect of 3 year LLB as well as five year BA LLB law course.

It is also to inform you that your college had applied for extension of approval of affiliation with requisite inspection fee from the academic year 2010-2011 for three year law course and as per the above resolution the approval of affiliation is extended till 2013-14. As per the Legal Education Rules – 2008, temporary approval of affiliation is to be recommended for not more than a period of three years (Chapter III, Rule 26(a)). Since the period of approval was extended for three years in respect of 3 year law course consecutively, the Rule 26(a) in Chapter III is applicable in your case.

So you are requested to apply afresh for extension of approval of affiliation beyond the academic year 2013-14 with required inspection fee of Rs.1,50,000/- for three year law course immediately failing which your college will not be allowed to admit students for the year 2014-2015. I am also enclosing the application form and check proforma which are to be filled up and sent in triplicate through the Registrar of the concerned University.
