#### OBSERVATIONS/DEFICIENCIES:

No access was available for online journals to the students and the same was pointed out during the last inspection committee also.

The computer lab of the college needs Air-conditioning, up gradation and of computers and addition printers.

Some of the equipment and books are still housed in the old premise of the college and the same should be available in the new campus.

The audio-visual room of the college needs improvement

The equipment in the lab needs up gradation and improvement from time to time and the faulty equipment be replaced immediately.

The record of the break up of salary was not available with the college. It has to be sent by the Management and not by the college particular salary of the staff.

The approach road to the college is in very bad shape and the inspection committee desired that the same be constructed/improved at the earliest.

The Principal of the College has not selected through University Selection Committee.

#### FINAL RECOMMENDATIONS:

After conducting inspection of the College, the Committee found the infrastructure, faculty and other facilities adequate for running B.Sc Nursing course.

The Committee recommends extension of temporary/provisional affiliation in favour of BEE ENN College of Nursing, Chak Bhawal, Jammu for the session 2014-15 for imparting instructions to B.St Nursing Course in light of the above said points by the Inspection Committee at the time of inspection for the academic session 2014-15.
