At the very outset Convener welcome members of the BOS and introduced the agenda:

#### **AGENDA:**

ITEM -1: To confirm the Minutes of Meeting of the Board of Studies in Education which was held on 07/12/2017 already circulated.

The Minutes of the Meeting held on 07-12-2017 already circulated were confirmed.

ITEM – 2: To introduce the Physical Education as a subject in Undergraduate program (CBCS) for Semester 1<sup>st</sup> and Semester 2<sup>nd</sup>.

The members deliberated the Physical Education curriculum prepared by the Department of Physical Education and Sports. The members took up the Schema and as well as the structure of the curriculum and discussed the various points in light of the proposed syllabus. After discussion the members approved the Physical Education Curriculum to be introduced at the Under-graduate level for Semester 1<sup>st</sup> & 2<sup>nd</sup> for the session 2019-20 (Dec. 2019,2020,2021 for lst Semester and May, 2020,2021,2022 for IInd Semester)

ITEM – 3: To deliberate upon the introduction of M.A Education in the offsite campus of the University of Jammu at Klshtwar.

The Members were briefed about the introduction of M.A Education as a regular course in the offsite Campus of University of Jammu at KIshtwar. The Convener briefed the members about the development and the background of the program and sought the opinion of the House for running the program at Kishtwar Campus. The members approved that M.A Education be introduced at PG level in the Kishtwar Campus, but with the rider that the Director, Kishtwar Campus would identify the faculty for teaching MA Education at Kishtwar Campus prior to the commencement of the program and the members also opined that Statutes, Schema and Syllabus (NCBCS) of M.A Education at Kishtwar be framed in accordance of the PG Level Statutes and the same may be approved by a Select Committee in BOS in Education for the session 2020-2021.

ITEM – 4: To introduce the M.A Education Program in Distance Education of the University of Jammu.

The members took up the item of Introducing M.A Education through Distance mode in DDE Jammu and the house approved the same. In this regard, the Statutes were thoroughly discussed and necessary amendments were moved and Prof. Darshana Sharma was requested to come out with the amended Statutes as well as the Scheme/Syllabus (NCBCS) of the M.A Education Program through Distance Mode on the pattern of M.A Education being run in the Department of Education in the light of the suggestions and amendments made by the members. The members agreed to run the program in M.A Education in the Distance Education with intake capacity of 50 students. The house resolved that statutes be approved after incorporating the necessary amendments as proposed in the BOS Education.

Prof. Renu Nanda, Head and Convener Board of Studies in Education welcomed all the participants and shared the agenda items already circulated by Registrar, University of Jammu.

## 1. To confirm the minutes of the meeting of the Board of Studies in Education which was held on 06-12-2017 already circulated

It was resolved that the minutes of the meeting of BOS in Education held on 06-12-2017 and 11.12.2017 be confirmed.

## 2. To Frame the syllabi of B.Ed and M.Ed (CBCS & Non-CBCS).

It was decided that in B.Ed propgramme total lessons shall be 50 (30+10+8+2) for each teaching subject in lieu of 60 lessons and same will be delivered by the pupil teachers in RCEM/Herbertian approach in third semester and Constructivist approach in fourth semester respectively from the session 2018-19.

M.Ed (CBCS and Non-CBCS) programme with 100 credits and shall be implemented from the session 2018-19. Therefore, all changes including note for paper setters (the question paper setting in M.Ed Programme for CBCS and Non-CBCS shall be similar) were discussed and approved by the BOS in Teacher Education and to be forwarded to the academic section for notification of the same.

## 3. To Frame the syllabi of BA-B.Ed and B.Sc-B.Ed

It was resolved that Statutes and Syllabus for BA-B.Ed and B.Sc-B.Ed shall be prepared by Members of the Board of Studies in Teacher Education under the guidance of Prof. Mubarak Singh. In this regard, faculty from Department

of Education, faculty from colleges, colleges of education and national experts shall be involved for preparation of BA-B.Ed and B.Sc.-B.Ed programme syllabus. The syllabus will be prepared in six months time as per national guidelines so that the BA-B.Ed and B.Sc.B.Ed programmes can be started from the session 2019-20.

4. To prepare a panel of paper setters/examiners to be sent to the Controller of Examinations, University of Jammu, Jammu.

The panel of paper setters/ examiners would also be compiled by the BOS in Teacher Education. BOS authorized Convener to prepare the panels for different examinations of 2018-2019.

5. To start New/ additional courses in Department of Education.

It was resolved that Statutes and Syllabus of integrated MA-B.Ed and PG Diploma in Guidance and Counselling shall be introduced in Department of Education, University of Jammu from the session 2019-20 and an additional in take of 25 seats of M.Ed programme under Self-Financed Scheme shall be started in Department of Education, University of Jammu from the session 2019-20. In this regard, permission may be sought from competent authority so that syllabus shall be prepared in time by the Faculty members of the Department and members of Board of Studies under the guidance of Prof Mubarak Singh.

The meeting ended with a vote of thanks to the chair.
