Following decisions were taken:

Item 1: Minutes of the meeting held on 29-05-2018 which were already circulated were confirmed.

Item 2: Change in Assessment & Examination Scheme for MBA (IB) Programme.

The members of the Committee deliberated upon the assessment and examination scheme of the MBA (IB) Programme proposed in the meeting of the Academic Council (7th Item & 47.2(b) rule as quoted in the annexure to Notification No. 2 of 2017, dated 08.09.2017) wherein it was resolved that the assessment and examination of 50% of the Courses shall be undertaken by external examiners. The MBA(IB) Programme offers 18 Core Courses in four Semesters, the committee resolved that for the smooth functioning of the department, second and fourth semester comprising of 09 Core Courses shall be subject to the new assessment scheme.

Item 3: Course Structure and Syllabus of MBA (IB) Programme

The Committee resolved to forward the Course Structure/syllabus of MBA (IB) Semester III & IV from December 2019 onwards (Session 2018 batch) for necessary approval.


Item 4: To Prepare the Panel of Paper Setters/Examiners.

Resolved that the Convener be authorized to prepare the Panel of Paper Setters and Examiners to be sent to the Controller of Examinations, University of Jammu.
