ITEM - 2) The 3 years BEd MEd (Integrated) Statutes, Syllabus and Schema was approved.

ITEM - 3) The two years BPed and Two years MPed programs of the Physical Education, University of Jammu were discussed at length in the meeting and it was found that the Statutes and Syllabus of both of the programs are not in conformity with NCTE norms applicable in University of Jammu since 2015. The faculty of Physical Education should complete this task in next two weeks from the date of approval of Minutes.

Item 1: To confirm the minutes of the minutes of the meeting of the Board of Studies in Teacher Education held on 24th May, 2018, already circulated

The minutes of the meeting of B.O.S. in Teacher Education held on 24th May, 2018 was read out by the Convener and it was confirmed by the members present in the meeting that they have not received the minutes of the said meeting and therefore action to be taken couldn't be taken up. In respect of the course curriculum Development, the members could not take up the action and as such expressed that an extension of two months from October till end December 2018 be given to frame the syllabus of B.A. B.Ed. and B.Sc. B.Ed. programmes in the light of the decision taken in the last meeting.

Item 2: To finalize the statutes of B.Ed. and M.Ed. (CBCS and non CBCS) programme of the University

It was resolved in the meeting that the DAA office would be requested about different versions of the statutes of B.Ed. and M.Ed. may be referred back to the Board of Studies in Teacher Education so that only one set of statutes could be finalized and can be tabled as an agenda in the ensuing meeting of the Academic council of the University of Jammu.

With regard to item no.2 I have to say that a committee was constituted vide order No. CDC/2017/1973-79 dated 1-08-2018 to incorporate the necessary statutes and Regulations of NCTE in the existing statutes/regulations of Education Programmes of the University. The draft statutes prepared by the committee were submitted to the Honible Vice-Chancellor vide Note No. DDE/SPA/18/3087 dated 25-5-18 for his perusal and approval. There is no need to refer the draft statutes to RAC in Tr Education, which have

been ~~been~~ prepared by the duly constituted Committee & already submitted to the Vice-Chancellor vide note No. DDE/SPA/18/3087 dated 25-5-18

Item 3: Possibility of Nai Talim, Experiential Learning and Community Engagement to be incorporated in B.Ed. and M.Ed. programmes of Teacher Education.

The members resolved to include Nai Talim, Experiential Learning and Community Engagement to be incorporated in B.Ed. and M.Ed. programmes of Teacher Education in the project work of M.Ed. by changing its nomenclature from the academic session 2019 onwards. It was further resolved that the evaluation of internship and project work of M.Ed. (CBCS and Non CBCS) programmes of Teacher Education would be evaluated henceforth by a panel of the external examiners at the nodal department.

Item 4: M.A. B.Ed. and B.Ed. M.Ed. integrated programmes:

This Item was discussed and as it is under active consideration of Board of Studies, so it was resolved that it would be taken up with the different state policy bodies as well as sister Universities in course of time so that its feasibility could be enhanced. In regard of preparing the course curriculum, the members decided to organize workshops to discuss the curriculum and related details by inviting national experts, State govt. officials, Colleges of Education and the Department of Education.


Item 6: Commencement of B.Ed. programme through DDE, University of Jammu for the session 2018-20.

Commencement of B.Ed. programme through DDE, University of Jammu for the session 2018-20 was discussed in detail and all the members gave their inputs which include that in case the B.Ed. programme has to commence from Directorate of Distance Education (DDE) University of Jammu, NCTE norms need to be withdrawn.


Item 7: To prepare a panel of paper setters/ examiners

The members decided that the panel of paper setters/ examiners to be sent to Controller of Examinations will be prepared by the Convener, Board of Studies in Teacher Education.
