OBJECTIVES OF THE PROJECT: The objective of the study was to use the study of folktales as a rich source of the socio-cultural data of the two regions to explore the value system of two communities i.e. the Dogras and the Kashmiris, that are a part of the single state but are distinct topographically, linguistically and culturally, to highlight the zones of cultural contact between the two regions and in the process unravel some of the similarities in the seemingly dissimilar cultures.
- 12. WHETHER OBJECTIVES WERE ACHIEVED OR NOT (GIVE DETAILS): The objectives were partially achieved because a lot of fieldwork involved visiting the region of Kashmir and the border areas of Jammu. However, due to escalation in the violence in Kashmir, not many visits could be

conducted in the region. Further, firing on the border villages of Jammu was also a major deterrent in the visit to those areas. However, many regions in the periphery and towns like Udhampur, Rajouri, Ahknoor, and Samba were visited. A visit to Srinagar and the surrounding areas of Gulmarg, Sonamarg, Yusmarg, Pahalgam and others was also made.

- 13. ACHIEVEMENTS FROM THE PROJECT: A comparative reading has served as a useful tool to know about the culture as a whole and also about the areas of overlap with the other cultures.

  Besides, the academic insights a few achievements of the project are as follows:
  - > Two project fellows have been trained in the course of the project as researchers
  - > Two Mphil Degrees have been awarded out of the project
  - > In the course of the project, the folktales that have been collected would provide a fertile terrain for further research
  - ➤ A few of the Dogri folktales that have been collected have been translated and are in the process of being published since all the primary data pertaining to Dogri folktales that was available in the library and archives of J&K Academy of Art and Culture, Jammu was destroyed in the floods of 2014.
  - > A similar initiative in case of Kashmiri folktales would follow
  - > This is an avant-garde study that looks at the folktales of the two regions in a comparative framework.

### 14. SUMMARY OF THE FINDINGS: (In 500 WORDS)

Folklore has long been considered as the quintessence of a culture, repository of its values and ideologies. The study was conducted with the objective of finding zones of cultural contact between the two communities. Hence the Dogri and Kashmiri folktales were analysed according to Vladimir Propp's *Morphology of Folktales* to examine if there is a structural similarity between the two. An analysis of the use of archetypes and myths was made to reveal a universal idiom embedded in both

the groups of folktales. Further, the tales were analysed vis-a-vis the gender codes embedded in them, the ethnographic particularities and identity with reference to 'self-concept', 'self-stereotype', 'ethnic character' and 'ethnic stereotype' as given by Alan Dundes alongwith the functions given by Propp that deal with the issues of identity.

In terms of Morphological analysis it was observed that the Kashmiri folktales fit the 'functions' given by Propp as much as do the Dogri folktales. There are both type of tales- simple and complex in both the categories and they break and conform to the functions a specified by Propp. In case of a study of Myths and archetypes, it was observed that both the categories of tales made use of certain universal myths like the Myth of Underworld Descent/Travel, the vegetation/fertility myth, Myth of transformation/Shape shifting. Both the categories of tales also reverberated with many archetypal characters, situations and symbols including the archetypal hero.

In case of representation of gender, many similarities could be observed in both the categories of tales since both the communities follow a largely patriarchal ideology. Though the women are not entirely subjugated or disempowered in the tales, the indications of a patriarchal set up are unmistakable. Many tales, however, represent women who are empowered and play a vital role in the tales, but they, too, do not go beyond or transcend the social expectations of the prescribed gender roles. As far as the emotions of love/marriage are concerned one again observes similarities in the interpersonal relationships of men and women. There are visible ethnic differences in the customs, rituals, dresses, linguistic markers, ornaments and the household items. But, the gender roles converge vis-a-vis the social expectations in both the communities. Closely allied to the gender roles is the concept of identity. As Bauman states, "Folklore is a function of shared identity". It is in fact one of the most important sources for the articulation and perpetuation of a group's symbols. A perusal of the tales established that identity is an important aspect of any tale. In most cases tales are woven around the issue of lost/mistaken/false identity or the quest to rediscover/uncover/establish

true identity. Anything from a birthmark to an heirloom can be a vehicle of establishing identity. Motif-Index of Folk-Literature consists of identity tests that may range from a scar (H51) to Birthmark (H51.1) to Branding (H55) to tokens (H80). All these can be found across folktales of both the regions. The inference in these tales is that identity itself is neither good nor bad and has to be looked at the cultural context. Further, though ethnic specificity of the identity is undeniable, certain traits that are universal may also be located in the characters.

### 15. CONTRIBUTIONS TO THE SOCIETY: (GIVE DETAILS)

The study of folk culture and oral tradition has paved way for understanding acculturation and patterning of the relations between culture and environment. Folktales of a community, in particular, employ different ways of self definition and characterizing the other. They are thus imbued with a dominant regional tone particular to that community and its culture.

A comparative reading provides a useful tool in testing theories or hypotheses about culture as a whole and about the areas of overlap with the other cultures, that is, the universal within the parochial. A study of folktales documents traditional behaviour, reinforces systems of belief, throws light on numerous aspects of social organization and interplay between cultures making the local material more useful to the social researcher, the ethnographer and the administrator.

In the state of Jammu and Kashmir this becomes even more useful as the two communities, the Dogras and the Kashmiri Pandits, are very diverse ethnic groups that have very different cultural and linguistic make up. However, beneath the differences there are certain similarities as well that can be built upon to create a discourse of unity rather than divergence.
