

- (iv) is not permanent resident of the territorial jurisdiction of the University of Jammu, but has passed/appeared in B.A./ B.Sc./ B.Com./ B.B.A/ B.C.A.(General or Honours examination, 10+2+3 pattern) with not less than 60% marks from a University other than the University of Jammu, subject to the condition that the number of seats under this category shall not exceed 10% of the total number of seats available in a programme of study.

Higher marks in the said examination shall determine priority in Admission.

f) Merit of the candidate who has passed class ^{2th} under 10+2 pattern from any recognized course.

(B) Selection Criteria For Achievement Categories.

NOTIFICATION AND FEE:

22. Names of the candidates selected for admission shall be notified from time to time on the Notice Board of the Concerned Department. The candidates shall be required to watch such notifications and comply with the instructions given in all respects failing which their selection shall be cancelled and no complaint will be entertained in this regard.

23. Admission fee and other charges payable by each student selected for admission to a programme of study shall be such as may be prescribed from time to time*.

PERMISSION FOR PRACTICALS TO PRIVATE CANDIDATES:

29. A Science Department may accord permission to members of the Laboratory Staff of the University, and such Teachers who hold at least 5 years of teaching experience in a school recognized by the J&K government, to perform the required number of practicals to earn eligibility for appearing in the Master's Degree Examination as a Private Candidate. Required teaching experience

This permission may be granted to one candidate each year on the basis of merit. This facility will not encroach upon the number of seats meant for open merit category. 1. Introduction

Ł

Lateral Entry Scheme is intended to admit 3 Years Diplorna in Engineering/B.Sc (Non Medical) degree holders to the Second Year/Third Semester of the B.E courses to acquire a Degree in Engineering and allows 10% seats of the sanctioned intake capacity, supernumerary to the approved intake in each stream of Engineering for admission through Lateral Entry System on full-time basis. The scheme already stands approved vide University Council Resolution No.75.20

2. Eligibility:

A candidate shall be eligible for admission in the Second Year/Third Semester B.E. programmes subject to the following conditions:

That the candidate is a permanent resident of J&K state.

- 2.2 That the candidate has passed Three Years Diploma in Engineering and Technology from an AICTE approved Institution with at least 50% Marks (40% in case of candidates belonging to reserved category).
- 2.3 That the candidate has passed B.Sc (Non Medical) Degree from a recognized University as defined by UGC, with at least 50% Marks (40% in case of candidates belonging to reserved category) and passed XII standard with mathematics as a subject.
 - 2.3.1 Provided that, students belonging to B.Sc (Non Medical) Stream, shall clear the subjects of Engineering Graphics, Machine Drawing and Engineering Mechanics of the First/Second Semester Engineering program along with the Third/Fourth Engineering Semester subjects.
 - 2.3.2 Provided further that, the students belonging to B.Sc (Non Medical) shall be considered only after filing the supernumerary seats in this category with students belonging to the Diploma Stream.

However, all the pre-conduct work of Entrance Examination like receipt of Online Application Form, Counselling of candidates, issuance of Admit Cards of Entrance Examination to the candidates, detailed Examination Schedule, any other related activities for smooth pre-conduct work of Entrance Entrance Examination and admission shall be dealt by the Dean, Faculty of Engineering.
- 6.2 Candidates with Diploma in Engineering will be admitted to the branch as per the preference given by the candidate in the application form and their Rank in LESET.
- 6.3 The students belonging to B.Sc (Non Medical) Stream shall be considered only after filling the supernumerary seats in this category with students belonging to the Diploma Stream.
- 7. Allotment of Seats:
- 7.1 The allotment of seats shall be made by the Admission Committee constituted by Dean, Faculty of Engineering, University of Jammu on the basis of the rank list published and availability of seats in the various categories according to the options given by the candidates. The admission shall be on the basis of Counselling. The candidate has to appear in person alongwith relevant documents at the time of counselling.
- 7.2 Once the candidate gets an allotment of the seat, the same shall be treated as final and binding.
- 7.3 In case of a tie among candidates securing equal marks in LESET rank/merit list, the final ranking will be in accordance with the following criteria:
 - (a) Candidate getting higher marks in Mathematics in the LESET shall be ranked higher in order of merit.
 - (b) In the case of a tie in Mathematics marks also, a candidate getting higher marks in the Physics in the LESET shall be ranked higher in order of merit.
 - (c) Still in the case of a tie in marks of both Mathematics and Physics, a candidate senior in age shall rank higher in order of merit.

8. Award of Degree:

- 8.1 The Overall result in case of the candidates admitted under Lateral Entry scheme shall be on basis of the marks secured by the candidates from 3rd to 8th semicisters only.
- 8.2 The marks secured in Engineering Mechanics, Engineering Graphics and Machine Drawing by B.Sc (Non-Medical) Degree candidates will not be reflected in the Overall result as these Courses are under eligibility criteria indicated at 2.3.1

3. Notwithstanding anything contained in the Statutes, the Statutes pertaining to Bachelor of Engineering Programme Course shall be applicable to the candidate admitted under Lateral Entry Scheme also.
