NOTIFICATION

It is hereby notified for the information of all concerned that the Vice Chancellor, in anticipation of approval of the Competent Authority, is pleased to authorize amendments in Statutes 5, 13-A (VIII) (d) and 13-D of the set of MCA Admission Statutes, as under:-

Existing	As it would read after amendment
<p>Statute 5(a) All candidates (including those belonging to categories identified in Statute 13-A) seeking admission to MCA shall be required to appear in a written entrance test to be designed and conducted by the Department of Computer Science of the University either itself or through an Agency approved by the Vice- Chancellor. The date-sheet, model test paper, syllabus and other details regarding the written entrance test shall be notified in the Bulletin of Information to be supplied along with the Application Form.</p> <p>(b) Admission of candidates under the open merit category and reserved categories i, iv, v, vi, vii and viii, as identified in Status 13-A, shall be made on the basis of merit in the Written Entrance Test of 100 marks.</p> <p>The seats for Universities other than University of Jammu will be filled strictly in order of merit obtained at the Entrance Test provided that no candidate from other University shall be admitted whose merit is lower than merit of candidate last admitted in open merit category of applicants who have graduated from Jammu University. This, however, shall not be applicable to candidates considered under viii(f).</p>	<p>Statute 5(a) All candidates (including those belonging to categories identified in Statute 13-A) seeking admission to MCA shall be required to appear in a written entrance test to be designed and conducted by the Department of Computer Science of the University either itself or through an Agency approved by the Vice-Chancellor. The date-sheet, Model Test Paper, syllabus and other details regarding the written entrance test shall be notified in the Bulletin of Information to be supplied along with the Application Form.</p> <p>(b) Admission of candidates under the open merit category and reserved categories i, iv, v, vi, vii and viii, as identified in Statute 13-A, shall be made on the basis of merit which will be calculated on the basis of percentile score (as explained below). All categories of open category as well as reserved categories except those belonging to the category of Scheduled Caste and Scheduled Tribe shall be required to secure at least 50 percentile score in the written entrance test for admission to MCA course, however for the candidates belonging to categories of scheduled caste and scheduled tribe the pass percentile shall be 40.</p> <p>The Seats for Universities other than University of Jammu will also be</p>

This, however, shall not be applicable to candidates considered under viii(f).

(c) A candidate seeking admission under the reserved categories (ii) and (iii), as identified in Statute 13-A, shall receive consideration under Statute 13-C, if he—

(i) possesses Bachelor's Degree of 10+2+3 pattern in any discipline with at least 50% of the aggregate marks as per Statute-3;

(ii) has not already availed of this concession for admission to any course in the Teaching Department of the University as per Statute 13-B. Admission of such candidates shall be made on the basis of merit determined in accordance with Statute 13-C.

13-A(VIII)(d) In the case of granting permission to appear as a private candidate in MCA examination the department may accord permission to compete at least irreducible minimum number of practicals to the employees of University of Jammu who held PGDCA of Jammu University or any other recognized university and have at least five years experience of

caste and scheduled tribe the pass percentile shall be 40.

The Seats for Universities other than University of Jammu will also be filled strictly in order of merit (expressed in percentile) obtained at the Entrance Test provided that no candidate from other University shall be admitted whose merit is lower than merit of candidate last admitted in open merit category of applicants who have graduated from Jammu University. This, however, shall not be applicable to candidates considered under viii(f).

(c) A candidate seeking admission under the reserved categories (ii) and (iii), as identified in Statute 13-A, shall receive consideration under Statute 13-C, if he—

(i) possesses Bachelor's Degree of 10+2+3 pattern in any discipline with at least 50% of the aggregate marks as per Statute-3;

(ii) has not already availed of this concession for admission to any course in the Teaching Department of the University as per Statute 13-B. Admission of such candidates shall be made on the basis of merit determined in accordance with Statute 13-C.

Explanation of computation of percentile: A candidate scoring x marks in the entrance test out of 100 marks will have percentile $(x/y)*100$ where y is the maximum marks scored out of 100 in the entrance test.

13-A(VIII)(d) In the case of granting permission to appear as a private candidate in MCA examination the department may accord permission to compete at least irreducible minimum number of practicals to the employees of University of Jammu who held PGDCA or B.E./B.Tech. Computer Science/ Information Technology from the Jammu University or any other recognized university and have at least

<p>programming or any other computer related job in the field of computer applications, provided they get permission from the competent authority of the University to do so. The permission may be granted to one candidate each year on the basis of merit in PGDCA. This will not, however, encroach upon the number of seats other wise meant for Open Merit category.</p>	<p>five years experience of programming or any other computer related job in the field of computer applications, provided they get permission from the competent authority of the University to do so. The permission may be granted to one candidate each year on the basis of merit in PGDCA or B.E./B.Tech. (as applicable). This will not, however, encroach upon the number of seats otherwise meant for Open Merit category.</p>
<p>Statute 13-D Separate marks for participating in each course/ camp/ event/ activity as mentioned in 13-C, I, II, III and IV shall be awarded. The selection of the candidates in categories (ii) and (iii) shall be made on the basis of performance in the respective categories as per schedule given in Statute 13-C and performance in the Entrance Test. 80% weightage shall be assigned to the marks obtained in the respective category and 20% weightage to the marks obtained in the Entrance Test. The final score of the candidate shall be determined by making use of combination of above weightage.</p>	<p>Statute 13-D Separate marks for participating in each course/ camp/ event/activity as mentioned in 13-C, I, II, III and IV shall be awarded. The selection of the candidates in categories (ii) and (iii) shall be made on the basis of performance in the respective categories as per schedule given in Statute 13-C and performance in the Entrance Test. 80% weightage shall be assigned to the marks obtained in the respective category and 20% weightage to the percentile score obtained in the Entrance Test. The final score of the candidate shall be determined by making use of combination of above weightage.</p>
