Applications are invited from all the eligible teachers/Deputy Librarians/ Assistant Librarians working in different Departments/Offsite Campuses/Directorates of the University, who are due for promotion **in the next Academic Level/Grade Pay** under Career Advancement Scheme in accordance with University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2010 & 2018.

The applications alongwith five sets of PBAS Proforma (**available on the University website www.jammuuniversity.in**) as prescribed by the University Grants Commission vide its Regulations, 2010 & 2018 duly forwarded by the concerned Head of the Department/Rector/Director should reach the Teaching Wing, New Administrative Block, latest by **December 20, 2018 (Thursday)**.

The applications duly filled in alongwith complete documentation regarding evidences of ISSN/ISBN Nos, Peer-Reviewed, Indexing/Abstracting etc. shall be placed before the Committee constituted for the purpose of verification of the API Scores and the cases complete in all respects, shall thereafter be considered for selection process/interviews.

For the pending cases for promotion from one academic Level/Grade Pay to another Academic Level/Grade Pay under the Career Advancement Scheme provided under the UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for Maintenance of Standards in Higher Education, 2010 and its subsequent amendments, the teachers can opt for consideration of their promotion from one Academic Level/Grade Pay to another Academic Level/Grade Pay as per the following:

- (a) In accordance with University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018.

OR

- (b) In accordance with UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for Maintenance of Standards in Higher Education, 2010 and its amendments with relaxation in the requirements of academic Performance Indicators (API) based Performance Based Appraisal System (PBAS) **as specified under clause VII, page 78 of UGC new Regulations, 2018.**

The incumbents not selected earlier by the Selection Committee can only apply after the requisite period as laid down in the UGC Regulations, 2010 and subsequent amendments issued by the UGC from time to time, is completed.

The Research score for research papers would be augmented as follows:

Peer-Reviewed or UGC-listed Journals (Impact factor to be determined as per Thomson Reuters list):

- i) Paper in refereed journals without impact factor - 05 Points
- ii) Paper with impact factor less than 1 - 10 Points
- iii) Paper with impact factor between 1 and 2 - 15 Points
- iv) Paper with impact factor between 2 and 5 - 20 Points
- v) Paper with impact factor between 5 and 10 - 25 Points
- vi) Paper with impact factor >10 - 30 Points

- a) Two authors: 70% of total value of publication for each author.
- b) More than two authors: 70% of total value of publication for the First/Principal/Corresponding author and 30% of total value of publication for each of the joint authors.

Joint Projects: Principal Investigator and Co-investigator would get 50% each.

Note:

- Paper presented if part of edited book or proceeding then it can be claimed only once.
- For joint supervision of research students, the formula shall be 70% of the total score for Supervisor and Co-supervisor. Supervisor and Co-supervisor, both shall get 7 marks each.
- For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b). Policy Document and 6. Invited lectures/Resource Person/Paper presentation shall have an upper capping of thirty percent of the total research score of the teacher concerned.
- The research score shall be from the minimum of three categories out of six categories.
