CIRCULAR

It is circulated for information of all the concerned eligible Teachers/Deputy Librarians/ Assistant Librarians working in different Departments/Offsite Campuses/Directorates of the University that:

1. Time and again all the concerned have been impressed upon to apply for promotion under said CAS rules against the circulars issued by the University from time to time;

2. It has been learnt that still there are eligible Teachers/Deputy Librarians/ Assistant Librarians who still have not applied for promotion under Career Advancement Scheme in the light of UGC Regulations, 2010 and UGC (2nd amendment) Regulations, 2013;

3. The Teachers/Deputy Librarians/ Assistant Librarians who were due to be considered for promotion under CAS before May 4, 2016 i.e. the date of applicability of UGC (3rd amendment) Regulations, 2016 and did not apply for the same, may submit their duly filled application in the Teaching Wing Section alongwith concrete justifications for delay in submission of their applications as to why they did not apply earlier;

4. Applications of those Teachers/Deputy Librarians/ Assistant Librarians shall be entertained who fulfill all the eligibility criteria in the light of UGC Regulations, 2010 and UGC (2nd amendment) Regulations, 2013 provided the reasons for delay were beyond their control and they were otherwise eligible. It is further clarified that the section will not hold the responsibility for these lapses on the part of said faculty, if any;

5. The applications accompanied with the PBAS Proforma as prescribed by the University Grants Commission vide its Regulations, 2010 and duly forwarded by the concerned Head of the Department/Rector/Director should reach the Teaching Wing Section, latest by November 27, 2017 (Monday).
